CONDITIONS OF PARTICIPATION

IN CONSIDERATION of the Participant being permitted to participate in any programs offered by Riders On Board Ltd. (the "Club") including, for greater certainty, any training, drop-in sessions, or coaching programs, or any combination thereof, organized, or offered by the Club (the "Programs"), the Participant acknowledges and agrees with Riders on Board Ltd. that:

1. The Participant will abide by all the rules, regulations and directions of the Club and its designated officials (written or verbal) pertaining to the organization and management of the program.
2. The Participant grants to the Club, its officers, employees, and agents the right to photograph the Participant's performances at the Program Events and the Participant's attendance in connection therewith and grant to the Club all title and right, including without limitation copyright, in and to such photographs to use as the Club sees fit without further consent or consideration being payable.
3. The Participant consents to receive such medical treatment as the medical staffs at the venue prescribe in the event that the Participant sustains, or is believed to have sustained, any injuries in connection with the program.

RELEASE, WAIVER OF CLAIM, INDEMNITY AND ASSUMPTION OF RISK

IN CONSIDERATION of the Participant being to participate in the Program, the Participant, on his/her own behalf and on behalf of his/her personal representatives, heir and next of kin ("Other Releasers") acknowledge and agree that:

1. The Participant and Other Releasers (the "Releasers") are aware that participation in, spectating at and/or merely attending the Program can be a dangerous activity involving MANY RISKS OF INJURY. The Participant understands that the dangers and risks of participation in, spectating at and/or merely attending the program include, but are not limited to: death, serious neck and spinal injuries which may result in complete and partial paralysis, brain damages, serious injury to virtually all bones, joints, ligaments muscles, tendons and other aspects of body, general health and well-being. The Participant understands that while some of these dangers and risks are inherent in the nature of the activities taking place during the Program some arise through the negligence on the part of the persons involved in preparing, organizing and staging and participating in, spectating at and/or merely attending the Program and may result not only in serious injury but in a serious impairment of future abilities to earn a living, to engage in other business, social, and recreational activities, and generally to enjoy life.
2. The Participant and Other Releasers are freely and voluntarily assuming any and all dangers, risks, hazards arising through participation in, spectating at, and/or mere attendance in the Program and further acknowledge that the Releasers are entirely at their own risk. The Releasers are not relying on any oral or written statements made by the Sponsoring Parties or their agents, whether in brochure, advertisement or in individual conversations to lead the Releasers to become involved in this Program or any basis other than the Releasers assumption of the risks involved.
3. Sponsoring Parties and their insurers, successors, assigns, administrators, heirs, executors, members, volunteers, shareholders, officers, directors, employees, contractors, agents, representatives, guides and their helpers and assistants and each of them and their respective administrators, and executors (the "Releasees") are not responsible for any loss, damage, personal injury or death to the Participant or other Releaser arising from the Participant participating in, spectating at and/or merely attending the Events and for any reason whatsoever, including without limitation negligence on the part of the Releasees or any of them.
4. The risks associated with the Program are increased when a Participant is impaired, and the Participant agrees not to participate if impaired in any way.
5. The Participant and Other Releasers hereby remise, release, discharge, waive, indemnify and save harmless the Releasees and each of them from any and all liability, costs, (including, without limitation, legal costs), claims, demands, damages, actions and causes of action at law and/or equity arising as a result of any loss, damage, personal injury or death suffered by the Releasers or any of them as a result, directly or indirectly, of the Participant participating in the Program and for any reason whatsoever, including without limitation, negligence or partial negligence on the part of the Releasees or any of them.
6. By signing this document the Releasers will be precluded from suing or otherwise claiming against the Releasees or any of loss, damage, personal injury or death that may be sustained through participation in the Program.
7. The Participant certifies that he or she is physically capable and fit to participate in these activities and that the Participant has no medical conditions or needs which have not been disclosed in writing to the Releasees.
8. The foregoing release, waiver and indemnity is intended to be as broad and inclusive as is permitted by law of the Province of Alberta and if any portion thereof is held invalid, the balance shall, notwithstanding, continue in full legal force and effect.
